Monthly Reports: Board chairpersons in attendance provided an update on recent committee meeting activities.

Finance/Buildings & Grounds: At the committee meeting earlier this evening, discussion was held regarding renovating the visitors locker room. The boys basketball club has offered to help fund part of the renovation project. Next year, roofing issues will need to be addressed. The Annual Budget Hearing will be held on October 16th at 6:00 p.m. The mill rate and levy will be presented. The hearing is open to the public. The committee meeting concluded with a walk through the school

forest.

Information/Action Items:

Legislative Update: Senator Duey Stroebel provided updates on the status of the state budget and the funding impact it will have on K-12 education.

Athletic Director Report: A. McKee provided an update on our sports teams.

Seclusion and Restraint Report: There were zero instances of a student involved in restraint and zero instances of a student involved in seclusion during the 2022-2023 school year. All protocols and documentation involving student discipline were followed appropriately and in accordance with state law. Motion to approve the report as outlined was made by S. Burmesch, seconded by D. Large. *Motion carried unanimously*.

Neola Policy Updates (2nd Reading): A variety of Neola policies were presented for second readings. A list of the policies are on page 24 of the board packet. A motion to accept the second reading of the Neola policies was made by S. Burmesch, seconded by J. Decker. *Motion carried unanimously*.

Other Post Employee Benefits (OPEB) Update: The District has an employee benefit trust fund to help cover future retiree benefits. When an employee retires, specific employees (based on years of service) are eligible for different allocations of money to be used for medical insurance premiums and medical expenses. J. McDaniel presented a summary of the actuarial study which determines the estimated liability related to the retirement benefits for the eligible employees.
