Motion to approve the resignation of Rebecca Kaja and the hiring of Emily Wollner as outlined, was made by S. Miller, seconded by S. Burmesch. *Motion carried unanimously.* 

**Monthly Reports:** Board chairpersons in attendance provided an update on recent committee meeting activities.

**Finance/Buildings & Grounds Committee:** The committee met earlier this month. Discussion was held regarding the operational referendum.

Information/Action Items:

Athletic Director Report: NOSD Athletic Director, Andy McKee provided the board with an update on the status of various sports. The high school boys basketball team are regional champions. Eight players on the high school girls team are Academic All State athletes. To be considered an Academic All State athlete, you must have a GPA of at least a 3.5 on a 4.0 scale. Two high school wrestlers made it to state. Middle school volleyball and wrestling are wrapping up their seasons. Track season starts soon. RLO Football, the co-op team combining Random Lake and Ozaukee football teams, has hired Cole Large as its head football coach. The board thanked Andy for his leadership, organization and dedication as the NOSD Athletic Director.

**Neola Policies (2<sup>nd</sup> Reading):** A variety of Neola policies were presented for second readings. A list of the policies are on page 23 of the board packet. Motion to approve the second reading of the Neola policies was made by S. Burmesch, seconded by D. Large. *Motion carried unanimously.* 

**OPEB Resolution:** The District participates in the Wisconsin OPEB (Other Post Employment Benefit) Trust. As part of this trust arrangement, the roles of trustee, custodian and financial advisors are selected by trust members. In the middle of 2023, BMO Harris Bank, N.A. notified the trust that it was going to resign from being the trustee and custodian of the trust. It was determined that Midwest Institutional Trust Company would fill those roles. Motion to approve the appointment of Midwest Institutional Trust Company as trustee and custodian of Wisconsin OPEB Trust was made by D. Large, seconded by J. Decker. *Motion carried unanimously*.

**Operational Referendum Update and Discussion:** D. Large reviewed the information contained in the *Operational Referendum April 2024 Flipbook of Key Facts*. D. Karrels discussed key points of the referendum handout that was created as a follow-up to the postcard that was mailed to residents in the District.
