**Ballot Question Resolution:** The following resolution was moved by S. Burmesch and seconded by H. Steffen:

Resolution Providing for a Referendum Election on the Question of the Approval of a Resolution Authorizing the School District Budget to Exceed Revenue Limit by \$1,100,000 Per Year for Four Years for Non-Recurring Purposes

Upon the vote being taken, the following voted:

The resolution was declared adopted.

Upon the ballot question resolution being declared adopted, D. Large explained why he voted "nay". It is his opinion that we should have asked to exceed the revenue limit by \$1,700,000 per year (the same amount asked for in the April election) so that the maintenance buildings and track could have been a part of the referendum.

**Neola Policy Updates (1st Reading):** S. Burmesch highlighted some of the policies that went through first readings at the Policy Committee meeting. Second readings will take place at next month's Board meeting.

**OHS Student Handbook Updates:** Matt Zavada, OHS Principal reviewed the current OHS Student Handbook. He worked with a few staff members to make a handful of adjustments. The revised pages were presented to the Board for review. Motion to approve the revised pages of the OHS Student Handbook was made by S. Burmesch, seconded by J. Clark. *Motion carried unanimously.* 

**Automotive Shop and Locker Room Tours:** Thank you to all who were involved in the work this summer on our Automotive Shop and Locker Room. These projects were made possible through the donations and work of local clubs, staff, contractors, community members and alumni. K. Schueller walked us through those areas, highlighting all the work that was completed this summer.
